Two hundred thirty-nine (239) calendar days will be allowed for completion of all work as described in the contract documents for Federal Project No. 6075(012), State Project No. 0075-0135 and the liquidated damages charge to apply will be One Thousand Five Hundred Dollars (\$1,500.00) per calendar day.

**Note: PRIME CONTRACTOR'S REQUIREMENTS:**

- A. Proposal Guaranty (Bid Bond): Except when otherwise specified, no proposal will be considered unless accompanied by a proposal guaranty in the form of a bond furnished by a surety company, satisfactory to the Engineer, in an amount equal to at least 30% of the amount of the bid, or unless the bidder has on file in the Town, an annual bid bond in the proper amount.

The apparent low bidder and second low bidder, as determined by the Town of Madison immediately after the bid opening, shall submit the Pre-award DBE Commitment Approval request form(s) to the Town of Madison no later than five days after the bid opening.
