

## SPS New England, Inc., e-mail dated February 29, 2024

- Question 1) Items for full depth deck repairs are included in the contract, but no shielding items have been included in the contract. Would the Department consider adding a shielding pay item to the contract? Response 1) Shielding shall be incidental to the reinforced concrete removal and deck repair items. See revised page A00801-63. Question 2) Would the Department consider adding a remove and reset barrier pay item to the contract? Response 2) This will be answered in a future addendum. Question 3) Can the Department clarify the limits of scupper drain removal? Response 3) Scupper removal shall only include the four (4) scupper locations on the Eliot Bridge, two (2) in each direction of travel. Refer to the "Scupper Removal Plan" on sheet 24 of 43 for limits of excavation for each individual scupper. Ouestion 4) The traffic control phasing does not cover the entire deck area. With the potential for deck repairs to be outside of work zones protected by barrier,
- potential for deck repairs to be outside of work zones protected by barrier, would the Department consider adding a rapid hardening concrete pay item to the contract?
- Response 4) This will be answered in a future addendum.

Question 8)	Sheet NO. 7 showing Junction Boxes in sidewalk. Details shown on sheet 10. There is no pay item or description for this. Please clarify.
Response 8)	This will be answered in a future addendum.
Question 9)	There are details shown on conduits in the barrier and conduit underneath the sidewalk. Please provide a detail for the 2" conduit crossing the road for the Navigation Lights.
Response 9)	Conduit is to run attached under bridge. Refer to Pay ITEMS 806.11 and 806.211 for conduit hanger systems.
Question 10)	Please clarify if a conduit expansion with a handhole will be required at the bridge expansion joints.
Response 10)	Provide expansion joints only, handholes should not be required.

## DOCUMENT 00813

#### SPECIAL PROVISIONS

### PRICE ADJUSTMENTS FOR STRUCTURAL STEEL AND REINFORCING STEEL

February 22, 2024

This special provision applies to all projects containing the use of structural steel and/or reinforcing steel as specified elsewhere in the Contract work. It applies to all structural steel and all reinforcing steel, as defined below, on the project. Compliance with this provision is mandatory, i.e., there are no "opt-in" or "opt-out" clauses. Price adjustments will be handled as described below and shall only apply to unfabricated reinforcing steel bars and unfabricated structural steel material, consisting of rolled shapes, plate steel, sheet piling, pipe piles, steel castings and steel forgings.

Price adjustments will be variances between Base Prices and Period Prices. Base Prices and Period Prices are defined below.

Price adjustments will only be made if the variances between Base Prices and Period Prices are 5% or more. A variance can result in the Period Price being either higher or lower than the Base Price. Once the 5% threshold has been achieved, the adjustment will apply to the full variance between the Base Price and the Period Price.

Price adjustments will be calculated by multiplying the number of pounds of unfabricated structural steel material or unfabricated reinforcing steel bars on a project by the index factor calculated as shown below under <u>Example of a</u> Period Price Calculation.

Price adjustments will <u>not</u> include guardrail panels or the costs of shop drawing preparation, handling, fabrication, coatings, transportation, storage, installation, profit, overhead, fuel costs, fuel surcharges, or other such charges not related to the cost of the unfabricated structural steel and unfabricated reinforcing steel.

The weight of steel subject to a price adjustment shall not exceed the final shipping weight of the fabricated part by more than 10%.

## Base Prices and Period Prices are defined as follows:

<u>Base Prices</u> of unfabricated structural steel and unfabricated reinforcing steel on a project are fixed prices determined by the Department and found in the table below. While it is the intention of the Department to make this table comprehensive, some of a project's unfabricated structural steel and/or unfabricated reinforcing steel may be inadvertently omitted. Should this occur, the Contractor shall bring the omission to the Department's attention so that a contract alteration may be processed that adds the missing steel to the table and its price adjustments to the Contract.

The Base Price Date is the month and year of the most recent finalized period price index at the time that MassDOT opened bids for the project. The Base Price Index for this contract is the Steel PPI listed in the Notice to Contractors.

<u>Period Prices</u> of unfabricated structural steel and unfabricated reinforcing steel on a project are variable prices that have been calculated using the Period Price Date and an index of steel prices to adjust the Base Price.

The Period Price Date is the date the steel was delivered to the fabricator as evidenced by an official bill of lading submitted to the Department containing a description of the shipped materials, weights of the shipped materials and the date of shipment. This date is used to select the Period Price Index.

The index used for the calculation of Period Prices is the U.S. Department of Labor Bureau of Labor Statistics Producer Price Index (PPI) Series ID WPU101702 (Not Seasonally Adjusted, Group: Metals and Metal Products, Item: Semi-finished Steel Mill Products.) As this index is subject to revision for a period of up to four (4) months after its original publication, no price adjustments will be made until the index for the period is finalized, i.e., the index is no longer suffixed with a "(P)".

### Period Prices are determined as follows:

Period Price = Base Price X Index Factor Index Factor = Period Price Index / Base Price Index

## Example of a Period Price Calculation:

Calculate the Period Price for December 2009 using a Base Price from March 2009 of \$0.82/Pound for 1,000 Pounds of ASTM A709 (AASHTO M270) Grade A36 Structural Steel Plate.

The Period Price Date is December 2009. From the PPI website\*, the Period Price Index = 218.0.

The Base Price Date is March 2009. From the PPI website\*, the Base Price Index = 229.4.

Index Factor = Period Price Index / Base Price Index = 218.0 / 229.4 = 0.950 Period Price = Base Price X Index Factor = \$0.82/Pound X 0.950 = \$0.78/Pound

Since \$0.82 - \$0.78 = \$0.04 is less than 5% of \$0.82, no price adjustment is required.

If the \$0.04 difference shown above was greater than 5% of the Base Price, then the price adjustment would be 1,000 Pounds X \$0.04/Pound = \$40.00. Since the Period Price of \$0.78/Pound is less than the Base Price of \$0.82/Pound, indicating a drop in the price of steel between the bid and the delivery of material, a credit of \$40.00 would be owed to MassDOT. When the Period Price is higher than the Base Price, the price adjustment is owed to the Contractor.

## End of example.

The Contractor will be paid for unfabricated structural steel and unfabricated reinforcing steel under the respective contract pay items for all components constructed of either structural steel or reinforced Portland cement concrete under their respective Contract Pay Items.

Price adjustments, as herein provided for, will be paid separately as follows:

## Structural Steel

Pay Item Number 999.449 for positive (+) pay adjustments (payments to the Contractor)

Pay Item Number 999.457 for negative (-) pay adjustments (credits to MassDOT Highway Division)

## Reinforcing Steel

Pay Item Number 999.466 for positive (+) pay adjustments (payments to the Contractor)

Pay Item Number 999.467 for negative (-) pay adjustments (credits to MassDOT Highway Division)

No price adjustment will be made for price changes after the Contract Completion Date, unless the MassDOT Highway Division has approved an extension of Contract Time for the Contract.

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union

average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

## WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
- \* an existing published wage determination
- \* a survey underlying a wage determination
- \* a Wage and Hour Division letter setting forth a position on a wage determination matter
- \* a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

# ITEMS 127.1, 127.4, and 127.41 (Continued)

1 Addendum No.1, March 8, 2024

Any damage to adjacent sound concrete incurred outside the repair area through negligence by the Contractor, and not acknowledged by the Engineer as being an extension of the repair area, shall be repaired by the Contractor at no cost to MassDOT.

After the designated portions of the existing unsound concrete have been removed, the exposed concrete surface shall be cleaned of all loose particles and loose rust by grit blasting, or other approved means, prior to placing the proposed repair materials. Surface preparation should be in accordance with the requirements of the patch material being installed.

Contractor shall have the approval of the Engineer certifying that all spalled and deteriorated concrete has been removed prior to commencing repairs.

The Contractor shall not allow for any grit or dust to escape the work area in a visible cloud or plume. All debris, dust, and grit shall be contained by draping the work area or other approved means and shall be collected and removed from the work area.

The Contractor shall submit, for approval by the Engineer, reinforced concrete excavation procedures that specify equipment, temporary shielding, and scaffolding to be used at each repair location.

# METHOD OF MEASUREMENT

Items 127.1 and 127.41 will be measured for payment by the Cubic Yard of reinforced concrete excavated.

Item 127.4 will be measured for payment by the Square Yard of reinforced concrete excavated.

## **BASIS OF PAYMENT**

- 1 Items 127.1 and 127.41 will be paid at the respective contract unit price per Cubic Yard, which price shall include all labor, materials, equipment, sawcutting, protective shielding, and all incidental costs required to complete the work.
- 1 Item 127.4 will be paid at the Contract unit price per Square Yard, which price shall include all labor, materials, equipment, sawcutting, protective shielding, and all incidental costs required to complete the work.
