#### **QUESTIONS**

- Q1. We are in receipt of Addendum #2, which changes the aluminum window specification. In order for the windows to be certified as large missile, they will need to be factory glazed. They cannot be open for glass by others. Additionally, pricing for impact rated windows takes approximately 2 weeks to get pricing on. Additionally, Section 08800 does not have impact rated glass specified. Please consider extending the filed sub-bid for the aluminum windows, changing the spec to have the windows factory glazed and update the glass and glazing specification to have impact glass?
- A1. The large missile impact testing requirement has been eliminated from the Contract Documents via a change to Specification Section 08520 Aluminum Windows by this Addendum No. 3. Therefore, the filed sub-bid opening date shall remain the same, and there are no changes to the glass and glazing specification requirements.

#### **SPECIFICATIONS**

1. Reference Specification Section 08520 – Aluminum Windows

Page 08520-2, delete Paragraph 1.05.C.6 revised by Addendum No. 2 and replace with the following:

"6. Additional test criteria for small or large missile impact is not required."
