

Question 1.) I am writing in regard to the Resurfacing and Related Work on Route 16 Project in Mendon, MA. Specifically, this Project is MassDOT Project Number 608491 and Bid Number BD-25-1030-0H100-0H002-119046; it is also Federal Aid Project No. NHP(NHS)-003S(866)X. The Project is currently specified with 12-, 15-, 18- & 30-inch Reinforced Concrete Pipe (RCP) Class III, 12-, 15- & 18-inch RCP Class IV, and 12-, 15- & 18-inch RCP Class V. Item Number and quantities are as follows:

241.12 = 12-Inch Reinforced Concrete Pipe Class III (4,135 LF)

241.15 = 15-Inch Reinforced Concrete Pipe Class III (2,740 LF)

241.18 = 18-Inch Reinforced Concrete Pipe Class III (705 LF)

241.30 = 30-Inch Reinforced Concrete Pipe Class III (15 LF)

243.12 = 12-Inch Reinforced Concrete Pipe Class IV (1,600 LF)

243.15 = 15-Inch Reinforced Concrete Pipe Class IV (245 LF)

243.18 = 18-Inch Reinforced Concrete Pipe Class IV (130 LF)

244.12 = 12-Inch Reinforced Concrete Pipe Class V (240 LF)

244.15 = 15-Inch Reinforced Concrete Pipe Class III (245 LF)

244.18 = 18-Inch Reinforced Concrete Pipe Class III (85 LF)

We would like to respectfully request that corrugated plastic pipe (both polyethylene and polypropylene; per AASHTO M294 and AASHTO M330) be allowed under the pipe option for the above referenced items. Both pipe materials are included within the Commonwealth of Massachusetts Department of Transportation Standard Specifications for Highways and Bridges (2025 Edition) Division III-Materials Specifications, Section M5.03.10 Corrugated Plastic Pipe. If allowed, the installation of corrugated plastic pipe would follow MassDOT Installation Guidelines. If additional information shall be required, please contact me at your earliest convenience regarding this request for a storm drainage pipe alternative. Thank you for your time and consideration.

Response 1.) The designer has specified RCP for this project as such the corrugated plastic pipe will not be allowed under a pipe option.
