

Have you heard anything back from DEP on the request for the work on the South Terminal bulkhead to be completed under a minor modification?

Thanks for raising the question on geotech data for the Shuster property and bulkhead. There were two borings east of the Shuster building advanced as part of the NBMCT site investigation work, and I've attached the logs and boring layout plan to this email. Let me know if you feel that these borings would be sufficient to support the scope of work discussed in the proposal related to the bulkhead/quayside. I appreciate your highlighting the limited extent of subsurface information available for the rest of the Shuster property, and would be comfortable with Foth's conditioning of the proposed loading limits within the report for the areas to the west of the quayside, or noting that additional subsurface investigation would be required in order to establish safe loading limits in those portions of the property.

We may be doing some sampling work on a portion of the Terminal in the next couple of months, so let's see if there is an opportunity to coordinate that work with the collection of additional geotech data.

I'll circulate the basics of the proposal with the rest of the MassCEC team and get back to you early next week with an update.
