ITEM 2-1: Drawing C-101

DELETE Drawing C-101 SECTION W10 PLAN AND PROFILE STA 110+50 TO STA 121+50 in its entirety and **REPLACE** with Drawing C-101 SECTION W10 PLAN AND PROFILE STA 110+50 TO STA 121+50, attached hereto as Attachment A, Addendum No. 2, Item 2-1.

ITEM 2-2: SECTION 02515 – STEEL PIPE AND FITTINGS

DELETE SECTION 02515 – STEEL PIPE AND FITTINGS in its entirety and **REPLACE** with the new SECTION 02515 – STEEL PIPE AND FITTINGS, consisting of 14 pages, attached hereto as Attachment B, Addendum No. 2, Item 2-2.

ITEM 2-3: SECTION 02516 – VALVES AND APPURTEANCES

Section 2.06.G

DELETE 2.06.G in its entirety and **REPLACE** with the following:

“G. Valve Bodies

1. Ductile Iron.
2. The valve body shall contain an adjustable stop, fastened to the valve body at a location 90 degrees from the valve shaft orientation, to prevent the valve disc

from moving past its closing point. The stop and all fastening materials shall be Type 316 Stainless Steel

3. *Flanged joints: Flanged ends shall be ANSI/ASME B16.1 Class 125. Flange construction shall comply with AWWA C115.*
4. Short-body type.”

ITEM 2-4: SECTION 02511–CLEANING AND CEMENT-MORTAR LINING WATER MAIN

DELETE SECTION 02511 – CLEANING AND CEMENT-MORTAR LINING WATER MAIN in its entirety and **REPLACE** with the new SECTION 02511 – CLEANING AND CEMENT-MORTAR LINING WATER MAIN, consisting of 12 pages, attached hereto as Attachment C, Addendum No. 2, Item 2-4.
