The items set forth herein, whether of omission, addition, or clarification, which supersede and supplement the reference portions of the contract documents, are all to be in the bid and form a part of the proposal submitted and become part of the contract documents.

ATTENTION ALL BIDDERS:

The period to submit questions has ended.

SUBMITTED QUESTIONS:

Question 1: Can you please confirm the liquidated damages for this IFB?

- Page 10 lists \$1,500.00
- Page 25 lists \$500.00
- Page 39 lists \$1,500.00

Response: *Liquidated damages is \$500.00/day.*

Question 2: It is indicated in the TOC that Items numbered 2 - 4 must be initiated/signed and returned with the bid. Can the bid sheet be revised to acknowledge agreement/understanding of these sections in the bid sheet rather than initial and submit 80+ pages of the IFB?

Response: The bid sheet has been revised so that only Items 2 and 3 need to be signed and returned and that receipt of the Prevailing Wage Information in Part 4 is acknowledged with the signing of the bid form.

Question 3: The project has to be completed by October 31, 2027. When do you intend for the Contractor to start work?

Response: It is anticipated that the Contractor will receive NTP by May 2026 and work will begin immediately after NTP.
